

ALBANY SENIOR HIGH SCHOOL

ENROLMENT SCHEME

Home Zone

All students who live within the home zone described below and shown on the attached map shall be entitled to enrol at the school.

The boundary starts on the Northern Motorway from the Upper Harbour Highway on-ramp. It follows the Northern Motorway north until it turns west on Bawden Road. At the start of Top Road off Bawden Road the boundary turns and continues in a straight line, south-west, to the end of Crossbridge Road. It includes Crossbridge Road and Highway 17 until the western end of Bawden Road. From this point it continues north along highway 17 to Green Road. It does not include this portion of Highway 17. Top Road and the greater portion of Bawden Road are not included.

The boundary then follows Green Road and continues west into Sunnyside Road. It runs along Sunnyside Road to the intersection with Robinson Road where it continues along Robinson Road across to the intersection of Sergeant Road. It runs south along Sergeant Road where it leaves the road and heads south across land to the top of Mill Flat Road. From here it includes the end of Rangitopuni Road and Croft Lane as it runs down Mill Flat Road to the Coatesville-Riverhead Highway. At this point it runs down the Coatesville-Riverhead Highway to Wake Road which it then follows to Ridge Road. It turns east along Ridge Road and then south into Brookdale Road.

The Boundary follows Brookdale Road to the nearest point to the Paremoremo Creek. From here it cuts across to the coast, including Iona Ave. It then follows the coast south and east all the way round Greenhithe to the Kereru Reserve.

At the eastern end of the Kereru Reserve the boundary continues again from the end of Kereru Grange. It follows Upper Harbour Drive, including Dene Court Lane, and then turns onto the Albany Highway, which it runs along until Sunset Road.

It then runs along Sunset Road all the way to the Northern Motorway and then up to the start point.

All residential addresses on included sides of boundary roads and all no exit roads off included sides of boundary roads are included in the zone unless otherwise stated.

Proof of residence within the home zone will be required.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date which will be published in a daily or community newspaper circulating in the area served by the school. This will enable the board to assess the number of places which can be made available to students who live outside the home zone.

Transition Arrangement 2009 - 2012

All the students who are enrolled and attending Albany Junior High School on 1 July 2008, who would be otherwise out of zone, will be entitled to enrol at Albany Senior High School because their address will be included in the home zone for the beginning of the school year in which they may move to the Senior High.


When each student on the list reaches Year 10 at Albany Junior High school, their address (if not an in-zone address) will be recorded and temporarily included in the Senior High zone for the following year's intake at Albany Senior High.

Their address will cease to be a part of the home zone:

(i) if the named student leaves Albany Junior High School otherwise (note if a student leaves Albany Junior High School before Year 10 the address not be added to the transitional list the following year);

(ii) the last day of February of the year following their Year 10 enrolment at Albany Junior High School.

This transitional arrangement is frozen for the Year 7 – 10 cohort enrolled and attending Albany Junior High School on 1 July 2008. Students enrolling after this date will not have a guaranteed ability to transition on to Albany Senior High. All students enrolling in 2009 will be informed that right of enrolment to the Senior High school is dependent on an in-zone address at the time the student enrolls at the Albany Senior High School.

Out of zone enrolments

Each year the board will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The board will publish this information by notice in a daily or community newspaper circulating in the area served by the school.

The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolment will be processed in the following order of priority:

- First Priority** This priority category is not applicable at this school because the school does not run a special programme approved by the Secretary.
- Second Priority** will be given to applicants who are siblings of current students.
- Third Priority** will be given to applicants who are siblings of former students.
- Fourth Priority** will be given to applicants who are children of board employees.
- Fifth Priority** will be given to all other applicants.

If there are more applicants in the second, third, fourth, or fifth priority groups than there are places available, selection within the priority group will be by a ballot conducted in accordance with instructions issued by the Secretary under Section 11G(1) of the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.
